## EastGroup Properties Announces 141st Consecutive Quarterly Cash Dividend

JACKSON, Miss., March 6, 2015 /PRNewswire/ -- **EastGroup Properties** (NYSE: EGP) announced today that its Board of Directors declared a quarterly cash dividend of \$.57 per share payable on March 31, 2015 to shareholders of record of Common Stock on March 20, 2015. This dividend is the 141<sup>st</sup> consecutive quarterly distribution to EastGroup's shareholders and represents an annualized dividend rate of \$2.28 per share. EastGroup has increased or maintained its dividend for 22 consecutive years and increased it 19 years over that period.
